Hereby covenant and agree as follows:

- 1. **Title Holder Obligations:** Title holder shall attend and participate in the Miss Gay Wisconsin USofA Pageant scheduled for which they qualified in its entirety. Title holder also agrees to represent their title at their appointed ‘step down’ at the end of their reign.
- 2. **Title Holder Responsibilities:** Titleholder agrees to hold the title, the USofA Pageant System, USofA Pageants and the State and Local Promoters and franchises in the highest esteem.

Title holder agrees that while appearing, entertaining, or representing the Title during the year of their reign to the following:

- a. Not to be drunk in a public place.
- b. Not to commit acts of a sexual nature in a public place.
- c. Not to commit acts of a violent nature in a public place or have legal proceedings resulting from malicious acts during the course of their reign.
- d. Not to use illegal drugs.
- e. Not to commit the act of stealing.
- f. Not to have a sex change operation.
- g. Not to participate in malicious gossip.
- h. To perform up to three times during their step-down evening as decided by the promoter.
- i. To have and keep an updated phone number provided to the promoter during the course of their reign.
- j. To reside within the required mileage for eligibility for Miss Gay Wisconsin USofA during the course of their reign.
- k. Not to perform nude.

- 3. **Promoter’s Responsibilities:** Promoter’s responsibilities to the Title Holder shall be:
 - a. To provide the Title Holder with all necessary information on a timely basis, as available, concerning pageants, bookings and obligations.
 - b. To pay all monies, awards and prizes, as long as Title Holder is not in default under this contract as follows:

- 4. **Certain Rights Reserved by Title Holder:** As long as the Title Holder is not in default under this contract, they shall have the following rights:
 - a. To enjoy the rights and privileges of said Title.
 - b. To be allowed bookings for a fee the titleholder deems reasonable and justified.

- 5. **Certain Rights Reserved by Promoter:** The following rights are reserved to Promoter:
 - a. To have and retain paramount title to the Title at all times
 - b. To reasonably set forth Rules and Regulations concerning the conduct of holders of the Title.
 - c. To set the dates, times and places of all future Miss Gay _____ WI USofA pageants with approval from State coordinators.
 - d. To make reasonable bookings for Title Holder. Said bookings will be confirmed with Title Holder at least ten (10) days prior to said bookings and said bookings shall be made in a manner as to not cause conflict with Title Holder’s schedule.
 - e. Promoter is only obligated those monies that were advertised and agreed upon with this contract to the Title Holder. All other monies are not part of this contract and are not to be expected or inferred by Title Holder.

- 6. **Promoter Remedies:** If the Title Holder defaults under this contract, Promoter may treat any one or more of the foregoing occurrences as a breach of this Contract and thereupon at its option may, with just cause and approval from the Promoters of Miss Gay WI USofA, exercise one of the following remedies:
 - a. Revoke the Title from the Title Holder
 - b. Demand the return of all prizes, awards, and/or monies given to the Title Holder. This includes the monetary value of non-cash prizes if said awards are not returnable.
 - c. Refuse entry into any of Promoter’s Preliminary Pageants in any capacity.
 - d. Pass the Title to the 1st Runner up or, if the 1st Runner up is not available or able, to any person felt is qualified to fulfill the obligations of the Title who competed at the specified contest of this contract.

- 7. **Miscellaneous:** The word “Promoter” shall be construed to mean Promoters in all cases where there is more than one promoter and necessary grammatical changes required to make the provisions hereof apply to corporations, individuals, or men and women shall be assumed as though in each case fully expressed.

- 8. **Release:** Title Holder agrees to release and hold harmless USofA Pageants, Promoter, and the Official Miss Gay USofA Pageant, their agents, servants, and employees, and licensees from any liability and/or responsibility whatsoever, resulting from, associated with, or arising out of Title Holder’s participation in the Miss Gay USofA Pageant System, in any duly franchised Miss Gay USofA Preliminary Pageant, and/or Title including, but not limited to, personal injury, or loss or damage to personal property regardless of whether the loss or injury occurs before, during, or after the Miss Gay Wisconsin USofA Pageant for which their Title will compete, the National Pageant, State or Regional Pageant and their related activities.

Title Holder also hereby releases himself from any rights to any video taping (sound and/or video), photography, recording, still camera, or motion picture of the Miss Gay Wisconsin USofA Pageant and related preliminaries or any duly franchised Miss Gay USofA Preliminary Pageant. Title Holder also understands that he has or will have no rights to any of the recordings arising out of said pageants that Title Holder may appear in or on, or the future sales thereof.
